# **ADMISSION REQUIREMENTS**

Applications to the program are due by the preferred deadlines of August 1 for fall admission and December 15th for spring admission. Applicants will be considered beyond these dates on a space available basis. Candidates for the MSRE degree must hold an earned bachelor's degree from an accredited college or university.

To apply, applicants must submit the following items to the Office of Graduate Admission:

- 1. Completed application form accompanied by a \$50 application fee
- Official transcripts of all undergraduate and graduate coursework
- 3. Letter of Intent (two double-spaced pages maximum) describing your interest in Real Estate, relevant past experiences, and career goals
- 4. Two (2) letters of recommendation attesting to your potential to succeed in graduate school
- 5. Resume
- If your first language is not English, an official report of TOEFL or IELTS results

Note: The GRE is not required for admission.

Students who complete the certificate will understand multiple aspects of the real estate profession including design, finance, management, construction, regulatory affairs, environmental conditions, and social policy.
