** _____ **Continuous housing needed (5/17/19 – 5/20/19)** A \$100 fee will be assessed to those students requesting continuous housing from the end of the spring semester until the beginning of summer session; this includes keeping belongings in your existing space. **All students for 3, 5, (1st session) and 10 week sessions will be permitted to stay in their current Spring assignment with the fee, until they can move into their summer assignment on Mon., May 20th between 2 PM and 3 PM.** Students who cannot be available to move on this date, or do not wish to incur the fee, must completely move out of their Spring assignment no later than Noon on Thurs. May 16th _____ (initial).

** _____ **Continuous housing needed (8/1/19 – 8/26/19)** A \$450 fee will be assessed to those students requesting continuous housing until the beginning of the academic year; this includes moving belongings only. **Students will be required to move into their permanent assignment at Noon, on Sun., Aug. 12th.** Students will not be permitted to move before or after this date. There are no exceptions. This is the only time that students must move into their permanent assignments unless. Your request for continuous housing cannot be granted unless you agree to be available for the move on Sun., Aug. 12th at Noon _____ (initial). If you are not assigned to University housing for the Fall, you will not be able to request continuous housing. **NOTE: UNLESS REQUESTED ABOVE (✓), OR RESIDING IN THE SAME APARTMENT FOR THE FALL, HOUSING IS NOT CONTINUOUS FOR THE ENTIRE SUMMER. Continuous housing requests CAN NOT BE ADDED after the April 22, 2019 application deadline.**

** _____ **Two summer course and housing discount.** Those students that are registered for university summer housing and registered for two summer courses (minimum 6 credits) are eligible for a \$250 discount on their summer housing charges. The \$250 credit will be applied to a student's account 2-weeks after the start of second class (to determine the student's enrollment status). Please note that this discount is not available for those students who are part of the "Scholar Program, Summer Conference Staff, Community Assistants or any other student whose housing is covered by another department/program".

Students who are currently assigned (Spring 19) in Bayside Seabreeze U (100's) will remain in their current assignment for the summer and will not be reassigned to another apartment. Summer applicants who reside in other living areas will be assigned to another space in Bayside Seabreeze U. Please make note of your Fall 19 assignment above. If you are staying for the 10 week session and your permanent Fall 19 assignment is located in Bayside Seabreeze U (100's), the Department of Residence Life & Housing will make every effort to place summer students into their permanent Fall assignment; however, this cannot be guaranteed. Should you be placed in your permanent assignment, you will automatically be assessed the additional \$450 fee listed above for continuous housing. Please refer to start and end dates associated with the session that you have selected above. Housing reserves the right to consolidate students during the summer to fill apartments.

I understand that I will comply with all University rules and regulations regarding housing policies as outlined in the RWU Housing Contract, the Student Handbook, as well as local, state and federal laws. I fully understand that any violation of such policies and or laws will result in judicial action and possible removal from University summer housing. I further understand that any damage caused by my negligence, willful or otherwise, will be paid by me upon receipt of notice from the University. I further agree to participate with other residents to pay for damages caused to common living areas if the person or persons responsible cannot be determined.
