Description of Organization and Mission:

Beat the Streets Providence is committed to starting scholastic wrestling teams in order to inspire at-risk youth and provide them with the support they need to succeed in school and in life.

Providence is struggling with inequity and underperforming schools. At the same time schools sports have been cut from Providence Middle Schools due to budget cuts. School sports are a proven and cost effective means to combat the very problems which plague Providence public schools. Beat the Streets Providence seeks to solve this problem by starting interscholastic wrestling teams in partnership with the city and community. We use co-educational wrestling to engage

struggling students in the after-school, connect them to strong mentors, provide academic support, and with a reason and incentives to attend school. Through high quality outcomes we believe we can be the catalyst to bring all sports back to Providence schools and in doing so help ensure every Providence student can find their pathway to success. Our vision is to bring school sports to every school in RI. This begins by having a Beat the Streets wrestling team in every school in Providence where sport has fallen victim to budget cuts. By funding and providing a high quality school sports program with high quality measurement we will be able to prove that for a relatively small investment school sports can have a powerful impact on the urban school system. Our goal is to use this evidence and our model to catalyze the return of school sports to all RI schools. These programs will be a crucial part of a larger RI community that leaves no one without access to the opportunities to realize their potential, both inside and outside the classroom.

Currently Beat the Streets runs programs in five Providence schools where we have reached 200+ students and improved attendance, health, and social emotional outcomes. Next year we will be in 10 schools and reach 500 students.

Title of the Project: Academic Programming Evaluation

A key part of our program is the academic support we provide to our students. Providence schools are struggling with academic performance. Our program is in the unique position where we are able to draw some of our schools most at-risk students and engage them in academic programming as a requirement of being on the wrestling team. We spend forty-five minutes before every wrestling practice engaging in homework help with volunteers. In it of itself this is having an impact because ~50% of Providence Middle School students do 30 minutes or less of homework in a week. However, at the same time we want to ensure that this is academic programming is not only working, but that it is the best use of this time period.

We would like to recruit Roger Williams education students to observe and evaluate our current academic programming. Based on their analysis of what we are already doing we would expect them either to develop and improved curriculum or training to enhance our current programming or recommend a new use of our academic programming period. Their evaluation and recommendations should be based in education pedagogy, best practices, and research to ensure that our academic programming is the cutting edge programming that our students need and deserve.

Current Academic Program Observation and Evaluation:

Students will begin by observing and evaluating our current program. Before students even visit the schools they will be expected to develop their own evaluation materials and criteria to determine the effectiveness of our programming so that when they do enter the school they will be able to make both qualitative and quantitative judgements on our academic program. Based on this observation and evaluation students will develop a rigorous report on the impacts and failures of our current program.

Academic Program Plan:

Based on their evaluation of our programming students will develop a new academic programming plan. This report will either recommend improvements to the current programming (curriculum additions, volunteer training, improved evaluation system, etc.) or replacement of the current academic program with a new model. These recommendations should both be based in established best practices and thorough research. Further, these recommendations should have a clear implementation plan that is efficient and possible with our resources, staff, and the rest of our program.

New Program Evaluation:

In the final part of the semester students will again evaluate the success of academic programming, but this time with the improved or new program model implemented.

What will be the final product output for this project? (survey, website, design plans, drawings, etc.)

Current Program Evaluation:

This report will be based in qualitative and quantitative data showing how our current academic program is succeeding and where it is weak. This report will be based both on research, observation, and qualitative/quantitative data taken from our students. This report will, thus, enable us to see the impact of our current program.

New Program Implementation Plan and Research Brief:

This report will be an actionable plan for how to improve our academic programming. It will include specific recommendations, down to the fine details of program implementation, as well as the research and rationale behind these recommendations. This plan will include curriculum, professional development, pedagogy, and impact evaluation.

New Program Evaluation:

Students will observe and evaluate, based on the same metrics developed earlier in the semester, the success of the new program model that is implemented. They will write a report showing the effects that this program has on students and what if any are its weaknesses and areas for improvement.

Program Observation: Start of semester

As soon as school returns to session our winter program will also be taking off. We would want students to begin program observation immediately.

Program Evaluation: March 1st

Program observation will continue until the end of the Beat the Streets winter session on March 1st. At that point students will be expected to provide and evaluation of the current program.

Program Implementation Plan and Research Brief: April 10th

By completing this report by April 10th we will be able to pilot immediately in our spring program.

New Program Model Evaluation: April 20th – May 20th

Please describe how this project will benefit your organization and the advancement of your mission: We are an education program first and a sports program second. For Beat the Streets wrestling is only the hook to improve students' chance of success in the classroom and in life. Academic success is integral to that success and to turning around the statistics in Providence schools.

This is a key part of our mission: "to start scholastic wrestling teams in order to inspire at-risk youth and provide them with the support they need to succeed in the **classroom** and in life."

This project will ensure that we are providing our students with the best academic support possible. We only have forty-five minutes every day to work with our students academically. If we are to hope that those forty five minutes will translate into success in the classroom we need to make sure we are using them as effectively as possible. We hope our partnership with Roger Williams will enable us to determine whether or not we are doing this. If it can it will advance our mission in a powerful way. Even if we are already running the best type of academic program for our organization and students this audit of that program will provide us with the academic backing to prove that it works and also enable us to refine this model so it has the biggest impact on our students. If it does not we will have the research and plan we need to implement a stronger academic model that will have a greater impact on our students success in the classroom.

Please describe how this project might benefit the overall community, including specific groups that could benefit from this project (i.e. target populations, neighborhoods, specific town/city/region).

Providence schools are struggling with underachievement. The statistics tell a sad story of inequity and underperformance and in a state with the third highest opportunity gap all compare poorly to the state as a whole:

- 35% of Students Chronically Absent
- 15% Drop Out Rate
- 71% Graduating in Four Years
- 34% Average NECAP Proficiency
- 8300 Incidents of Suspension
- 80% of students eligible for free and reduced lunch
- 20% of students ESL

At the same time over the past decade sports have been cut from Providence Middle School budgets and diminished at the high-school level. As a result, only 22% of RI students are engaged in after-school programs. This small percentage

of students has been proven to see the greatest gains in school while for the most part the rest, approximately 50% of Providence students, will leave school and be unsupervised from 3-6 pm. The loss of sports represents an important missed opportunity to reengage failing students in school. Research has proven that student athletes are more likely to attend school, feel more connected to school, report higher grades, experience better overall health, and are more likely graduate and attend college.

This program would directly impact the academic success of 500 of the most at-risk Providence Middle School students. We target students who are eligible for free and reduced lunch, chronically absent, demonstrating at-risk behaviors, and performing poorly in their classes. Turning around the success of those 500 students in the classroom would have a powerful impact on the Providence community.

Please explain why you have chosen to seek assistance from the RWU CPC with your project request, instead of undertaking the project using fee-for-services from a paid professional:

We are a start-up non-profit in only our third year and are doubling the size of program in the coming school year. As a result, the majority of our funding goes directly to providing services for our students. Investing large amounts of funds in program redesign would detract from what we can provide to our students in the short term. Further, it is not clear that our program needs to be redesigned. Before we contract with a paid professional to do so we need to make sure that it is a necessity for the long term success of our program.

Please describe how this project will benefit RWU students.

This project will provide RWU education students the opportunity to work in a school and put what they have learned in the classroom to real world use. These students will use their knowledge of education to design a real curriculum that will be used in Providence schools. Further, they will have the extraordinarily rewarding experience of making a difference in the lives of youth who need their support.
