#### Additional Comments

The Architecture Programs--BS in Architecture, Master of Architecture--in 2008/09 charged \$29,256 tuition per year, other programs \$25,256--a tuition differential of \$3,298-- in recognition of the level of support given the programs. Credits over 17 per semester are charged at \$1,219 in Fall/Spring.

Summer coursework was offered for Undergraduates at a rate of \$267 per credit, with a a Design Studio Fee of \$1,600 for 5 credit Architectural Design Studios. Summer coursework for Graduate Students was offered at a rate of \$800 per credit, with a Design Studio Fee of \$1,600 for Graduate Architectural Design Studios. Approximately 50 Undergraduate and 35 Graduate students enrolled in Summer Design Studios in Summer 2009.

#### Physical Resources/Information Resources

NAAB Response to RWU 2008 Annual Report: The program is requested to continue reporting on this cause of concern; in particular, the results of the summer 2009 shelving installation. While not required, an updated floor plan of the library along with images would be helpful.

RWU 2009 Annual Report Response, prepared by John Schlinke, Architecture Librarian: The branch library that serves the School of Architecture, Art and Historic Preservation (SAAHP) at Roger Williams University has been faced with space constraints, particularly with regard to the growing collections of monographs and bound periodicals. During the 2003-2004 Winter intersession a new range of steel shelving (150 linear feet) was purchased and installed on the second floor of the library. The existing shelving and lighting was shifted to accommodate the new range, and the new shelving allowed for the continuing growth of the monograph collection. During the 2005-2006 winter intersession, a more substantial remodeling was carried out resulting in an additional 210 linear feet of new shelving for the monograph collection and 144 linear feet of new shelving for the bound periodical collection. At the time the shelving was installed, it was estimated it would accommodate growth of the collections through summer 2009, and to date this estimate has proven to be accurate.

A new remodeling plan was designed and implemented in 2009. Using existing shelving that had been in storage, the redesign has provide an additional 225 linear feet of shelving for monographs at a cost of approximately \$2,500. As part of this work, the current periodical collection (on display shelves) was shifted and compressed by shelving three issues per shelf rather than the current two. The increased density has benefited our users by making the collection easier to browse, and its new location makes it a focal point of the library. To accommodate growth in the bound periodical collection, weeding of duplicate journal back issues was begun in 2008 and completed in 2009. The weeding has resulted in 54 linear feet of shelving for growth. At current rates of growth, it is estimated that the combined steps of the redesign will allow for another three years of growth in the collections at a minimum (summer 2009 – summer 2012).

#### Changes to the Accredited Program

#### 1) Phase-Out of Bachelor of Architecture program, 2009

NAAB Response to RWU 2008 Annual Report: "The program reports that its final cohort of the Bachelor of Architecture degree program will graduate in May 2009. Will all students in this final cohort graduate or will there be any students unable to graduate and need additional time to graduate with the BArch?"

RWU Response to NAAB 2008: There are three students who were not able to register for two final required courses for the B.Arch. degree as scheduled in 2008/09, two due to illness, one due to having to repeat a course—Alexander MacNeill, Ronit Malekan, and Charles Talmadge. All of these students have been enrolled in 2009/10 in their final Architecture requirements for the B.Arch. degree-- in Fall 2009 they have enrolled in Arch 541 Independent Project Proposal Seminar, and are enrolled for the Spring 2010 semester in Arch 514 Independent Project Design Studio. If these students complete these courses successfully, they will complete the B.Arch. requirements and graduate in May 2010, and the B.Arch. will be completely taught out.

There were approximately ten students who had enrolled in the Arch 514 Independent Project Design Studio in Spring 2009, who received Incompletes and were still at work completing their course requirements through the Summer, but these students have completed the course offerings.

## 2) Changes in Faculty, 2007/08 onward : Establishment of Visiting Professorships, Visiting Teaching Firm in Residence

The establishment of Visiting appointments in Architecture and other areas of the School since 2007/08 that have been filled by distinguished practicing architects and critics has helped to

increase our diversity, and our connection with the architectural education and practice in the region and in some cases internationally.

## 3) Changes to the Accredited Program—BS in Architecture / Master of Architecture Sequence, Curriculum Development

We are currently at work revising our BS in Architecture/Master of Architecture program sequence, partially in response to the <u>2009 Conditions of Accreditation</u>. Features of these revisions, among others in a comprehensive curriculum review, include increases in coverage of Sustainability and Integrated Practice issues though:

- Sustainability at the undergraduate level through the revision of our General Education requirements to include a new two course lab requirement inclusive of Physics I and either Biology 104 (which includes a substantial ecology component) or Envr Science 103 Earth Systems Science and Lab
- Increased attention to Sustainable Design in Arch 313 Design Core Studio V, which as a
  capstone of the current five semester Core we believe is a logical place to focus on
  sustainable design and a level of comprehensive design at the mid-point of the
  BS/M.Arch. sequence.
- With the requirement of Physics I, we expect to reduce the number of Structure courses from four to three, allowing for the creation of a new required Computer Applications for Integrated Practice (tentative title) course at the graduate level. This course will involve building systems integration (including structure, mechanical systems, skin), simulation, BIM, construction cost control as students prepare for their required Comprehensive Project Design Studio.

The program will be voted on by the School faculty in December 2009, for recommendation for the 2010/11 catalog.

## 4) Changes to the Accredited Program—exploring change of current BS/M.Arch. dual degree to 4+2 BS + M.Arch. sequence

We are exploring converting our current BS/M.Arch. dual degree, where students are awarded both degrees upon completion of all requirements, to a more traditional BS in Architecture +

Master of Architecture, where undergraduate students at Roger Williams would graduate after completion of 4 year requirements and then move into the Master of Architecture, or exit the school to pursue employment or other educational opportunities. Accelerated entry into the M.Arch. could still be possible, but this change would provide a clearer threshold between undergraduate and graduate programs, and help in a variety of ways—including undergraduate time to graduation timelines and degree completion.

## 5) Development of a new Accredited Program--Master of Architecture (external entry, 3.5 years)

Roger Williams University is considering developing the Master of Architecture, 3.5 year duration, for those with a baccalaureate degree in another area, to complement the BS/M.Arch. dual degree sequence currently in place.. We are referring the 2009 Procedures for <u>Accreditation</u> in this process.

6) Development of Post-Professional Master of Science in Architecture
We are also at work on developing a post-professional Master of Science in Architecture
program, with concentration options initially envisioned in Sustainable Design, Historic
Preservation, and Digital Media. Further concentration potentials in Urban Design, and
Construction Management are also under consideration.

Central goals of developing the MS in Architecture are:

- To provide post-professional specialty concentrations to Master of Architecture students
- To provide faculty development opportunities for faculty at the graduate and postprofessional program level
- To extend the reach of the School to engage the architecture professional community in coursework on a part-time or full-time basis, in residence or on-line.
