Further developments in this area since the 2009 Annual Report:

The School is undertaking several endeavors to increase experiences of Social Diversity, in curriculum and outreach opportunities:

- For the 2010/11 catalog, the School has created a required Arch 416 Advanced Topical Design Studio: Urban/Community, where all students engage external, more culturally diverse groups as part of program requirements. These undertakings involve Rhode Island communities, communities in need such as Haiti in 2010, and the Florence Program. This effort is being phased in to be available to students following previous catalog requirements as well.
- The School is actively engaged in establishing a Design and Conservation Assistance Center (working title) in conjunction with the RI Economic Development Commission and other groups around the state, in order to serve the Rhode Island community in design and historic preservation related projects, on a pro bono basis. This effort is being enthusiastically supported by the University.
- Commencing in 2010, the School has begun a two year cycle of semester-long Graduate Study Abroad experiences with the following international institutions:
 - o Fall 2010: Universidad Torcuato di Tella, Argentina
 - Spring 2011: Tsinghua University, Beijing
 - o Fall 2011: Istanbul Technical University, Istanbul

Spring 2012: School of Planning and Architecture, Delhi

The sites were chosen to create a network of opportunities for students to engage with cultures and architecture outside of the US and Europe. Each experience includes significant contact with or internships for students in architecture offices at each site.

Further developments in this area since the 2009 Annual Report:

Continued Development of the University's Visual Resources Collection

In Spring 2005 the Visual Resources Center (VRC) began to transition from a slide-based image collection to a digital-based image collection. At that time, the architecture and art slide collection numbered approximately 80,000 images. Over the past five and one-half years, the Library has maintained the slide collection while building a new digital image database and providing access to ARTstor, the subscription-base database of art and architecture images. The resulting digital image database (MDID) now comprises some 89,000 images and is continuing to grow, based on faculty and student needs. ARTstor has also grown substantially, with over 1.2 million images now available.

As the VRC has transitioned to digital images, the fields of architecture and art/architectural history have made a similar transition. The vast majority of faculty and students now use digital images as their preferred image format. The transition has also brought dramatic changes in the use of the collections. Faculty members can now compose and access image lectures from anywhere with web access. They no longer have to come to the VRC location to put together a carousel of slides and return the slides afterwards. Similarly, students can now use MDID and ARTstor from anywhere to review a set of examination images or write a comparative essay on two built works.

The Library believes this digital transition will allow the VRC to be moved to the Main Library from its current home in the Architecture Library without compromising service or collections for the SAAHP. Doing so will provide an opportunity to address two important unmet needs at RWU:

- 1. The Architecture Library collection continues to grow and will require additional space to house it. Moving the VRC will provide an additional 640 square feet in the Architecture Library for this purpose.
- 2. Moving the VRC to a more prominent campus location will promote its services and collections to the entire RWU community as well as potentially support student uses of technology.

Moving the VRC to the Main Library is contingent upon space becoming available for this purpose in the Main Library (from the potential relocation of an academic department currently housed within the library) and capital funding being available for the VRC move and interior library renovation work.

2) Changes to the Accredited Program, 2010/11 Catalog requirements— 4+2 BS in Architecture + Master of Architecture Sequence

The BS in Architecture/Master of Architecture program sequence has been revised for the 2010/11 catalog, partially in response to the 2009 Conditions of Accreditation. Features of these revisions among others in a comprehensive curriculum review, include reduction in credit totals (from 186 credits to 181) increases in coverage of Sustainability, Integrated Practice, Cultural Diversity issues though:

- Increased attention to foundations of sustainability through the revision of our General Education requirements to include a new two course lab requirement inclusive of Physics I and either Biology 104 (which includes a substantial ecology component) or NATSC 103 Earth Systems Science and Lab
- Increased attention to sustainability in Arch 313 Design Core Studio V, which as a capstone of the current five semester Core we believe is a logical place to focus on sustainable design and a level of comprehensive design at the mid-point of the BS/Master of Architecture sequence.

- Increased attention to Integrated Practice: the revision of the Arch 488 course Computer Applications for Professional Practices at the graduate level. This course involves building systems integration (including structure, mechanical systems, skin), simulation, BIM, construction cost control as students prepare for their required Comprehensive Project Design Studio. The course is being offered in a team taught format, with full time design, computing and professional practices faculty collaborating, along with adjunct faculty enrichment/connection to the profession.
- Increased attention to cultural diversity/community diversity through the creation of a required Arch 416 Advanced Topical Design Studio: Urban/Community, where all students engage external, more culturally diverse groups as part of program requirements. These undertakings involve Rhode Island communities, communities in need such as Haiti in 2010, and the Florence Program.
- <u>Increased attention to cultural diversity/varieties of practice</u> through has begun a two year cycle of semester-long Graduate Study Abroad experiences with the following international institutions:
 - o Fall 2010: Universidad Torcuato di Tella, Argentina
 - o Spring 2011: Tsinghua University, Beijing
 - o Fall 2011: Istanbul Technical University, Istanbul
 - Spring 2012: School of Planning and Architecture, Delhi

2) Changes to the Accredited Program—changing the BS/Master of Architecture dual degree to a 4+2 BS + Master of Architecture sequence

For the 2010/11 catalog, we have de-coupled the dual degree format, converting our current BS/M.Arch. dual degree, where students are awarded both degrees upon completion of all requirements, to a more traditional BS in Architecture + Master of Architecture, where undergraduate students at Roger Williams graduate after completion of 4 year requirements and then move into the Master of Architecture, or exit the school to pursue employment or other educational opportunities. Accelerated entry into the M.Arch. could still be possible, but this change would provide a clearer threshold between undergraduate and graduate programs, and help in a variety of ways—including undergraduate time to graduation timelines and degree completion.

3) Development of a new Accredited Program—3.5 year duration Master of Architecture option (2012/13 catalog)

Roger Williams University is developing a 3.5 year Master of Architecture program option, for those with a baccalaureate degree in another area, to complement the 4+2 BS + Master of Architecture sequence currently in place. The current plan is to introduce this new degree track for Fall 2012, to allow sufficient time for marketing/public information.

4) Development of Post-Professional Degrees: Master of Science in Historic Preservation (2010/11 catalog), Master of Science in Architecture (2012/13 catalog)

The School has developed two different post-professional options over the past year:

- M.S. in Historic Preservation (2010/11 catalog)
- M.S in Architecture--with concentration options in Sustainable Design, Historic Preservation, Digital Media, Urban Design--(2012/13 catalog)

The M.S. in Historic Preservation has a one year program track for those with an undergraduate degree in Historic Preservation, and a two-year track for those with undergraduate degrees in any field, or a professional degree in Architecture. In its first year, the M.S. has attracted 8 new students, with 15 expressing interest for Fall 2010. To date, none of the students are Architecture professional degree holders, but the program is open to those with this background.

The post-professional Master of Science in Architecture program, with concentration options in Sustainable Design, Historic Preservation, Digital Media and Urban Design is a one year and one summer program, which

includes advisement options for FT day students, PT students, and concurrent enrollment in the Master of Architecture.

Central goals of the MS in Architecture are:

- To provide post-professional specialty concentrations to Master of Science students
- To provide faculty development opportunities for faculty at the graduate and post-professional program level
- To extend the reach of the School to engage the architecture professional community in coursework on a part-time or full-time basis, in residence or on-line.
