## **PSYCHOLOGY**

Psychology is the study of how people think and act, and the relationship between the mind and body. It's common to think of psychologists interviewing people in clinical settings, but they also research and investigate thought patterns and behavioral motivations to answer questions across a wide variety of fields. Psychologists apply their skills and methods to help solve problems in our community and society.

#### **Learn and Do More at RWU**

With a focus on experiential learning at RWU, psychology majors can:

- Collaborate on research with faculty members who are experts in their field.
  Students regularly co-author papers such as balancing the responsibilities of work and family life, learning differences
  - learning differences between the genders, and multicultural aspects of sexual aggression.
- Partner with community organizations and businesses to solve problems that matter to them. Examples include promoting mental health well-being with youth in Jamaica, working with the Bristol Health Equity Zone to study the impact of community cooking demonstrations, and analyzing policies and programs at an elementary school in Providence and at Head Start in Fall River.
- Sharpen their research presentation skills at regional, national, and international conferences like the Association for Psychological Sciences in Vienna, Austria, the Eastern Psychological Association, and the Association for the Treatment of Sexual Abusers.

#### **CURRICULUM**

During your first two years, you will learn the major psychological theories, and understand what psychologists do and the methods with which they work. You'll also learn how to use software-based statistical techniques to answer psychological questions in research projects.

Your third and fourth years focus on research methodology and dive deep into specialized areas of psychology. You'll learn descriptive and experimental methodology, how to conduct observations and surveys, examine case studies, and develop a research proposal. Through group research or an individual thesis project, you will take a research question through the scientific process including sample development, data collection, and analysis. You will then present your findings to peers and faculty members.
